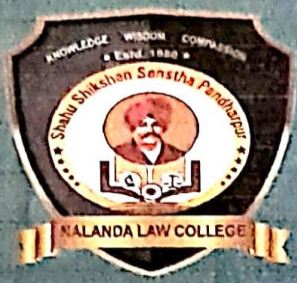

Percentage of full-time teachers appointed against the number of sanctioned posts



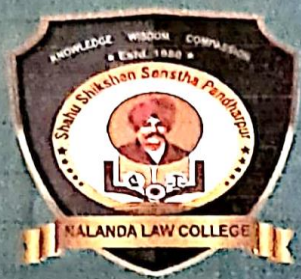

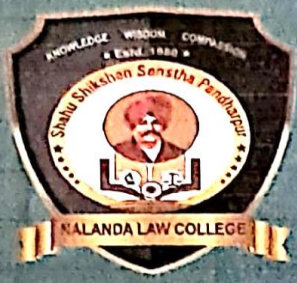
