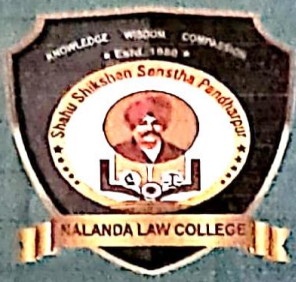

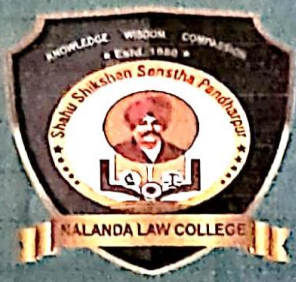

## STUDENT CENTRIC ICT TOOLS

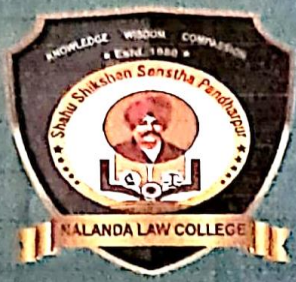
