take any action against accused no.1. Hence, complainant filed complaint

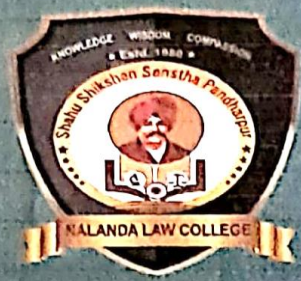
