POINTS DISCUSSED:

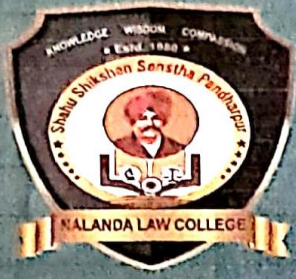
1. On 19 September 2018, a grievance was received.
