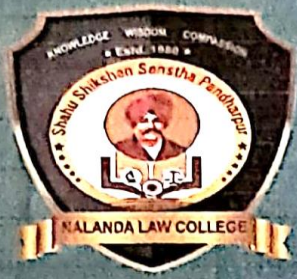

bar council.**



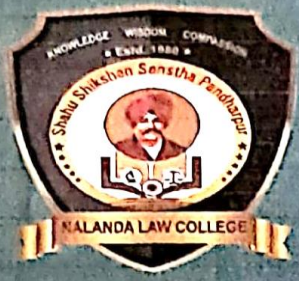

state bar council.**



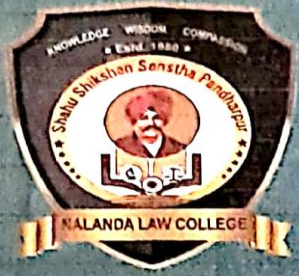
