## Policy Document on Providing Financial Support to Teacher

### PROVIDING FINANCIAL SUPPORT TO TEACHERS FOR ATTENDING CONFERENCES AND WORKSHOPS

#### Preamble:

The policy of providing financial support to teachers is in place to enable them to attend conferences and workshops organized by reputable national and international institutions, universities, colleges, and towards membership fees of professional bodies.

#### Objectives:


1. To encourage teaching staff to present research papers at conferences of national and international significance.
2. To assist teaching staff in seizing opportunities to discuss novel developments, emerging challenges, and future perspectives in their fields of interest.
3. To support teaching staff in promoting teaching-learning, research extension activities, and governance through participation in conferences and workshops.
4. To enhance their academic credentials in accordance with expectations.

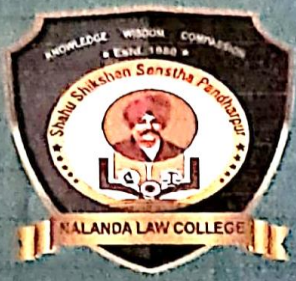
Policy regarding attendance of conferences/workshops/seminars:

Regular faculty members are permitted to attend conferences/seminars/workshops at the international level once every four years and at the national level once per financial year at government expenses (i.e., registration fee + travel allowance), subject to the fulfilment of the following conditions:

1. The faculty member must present a paper or chair a session and must have been officially invited to do so.

2. Sufficient funds must be available for this purpose within the department.
3. The conference/seminar/workshop must be in the public interest.
4. At least 50% of the faculty should be on duty at the college at the time.
5. Daily allowance (DA) will not be paid, and faculty members will be granted academic leave. For local conferences, only the registration fee will be covered, and academic leave will be granted.
6. Compliance with instructions issued by the Government of India regarding travel abroad.
7. For international conferences, the applicant must have successfully completed their probation.
8. Only 20% of the teacher's strength in a department may be deputed for international conferences, etc.
