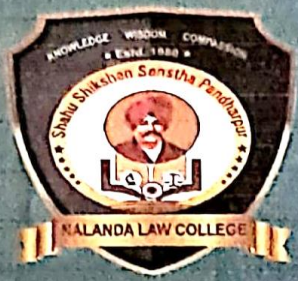

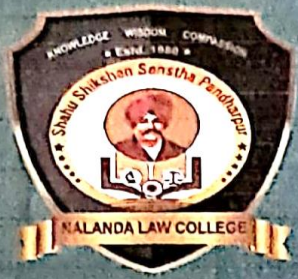

The goal of the activity is: Giving practical experience in the legal profession should be the main priority for a number of reasons.

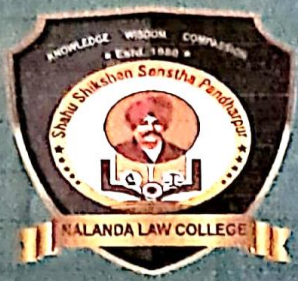

4. The Practice: Each semester, the individual law colleges are given 25 marks for conducting internal examinations.

These 25 scores are divided into three to four parts by Rizvi Law College, which then administers an internal exam. Each semester, each class engages in unique activities that are assessed by both internal and external instructors. After that, the grades are turned in to the University of Mumbai in the strictest confidence.

2. Writing an article and using Vivas simultaneously - 10 points


3. Jam Sessions: Five points

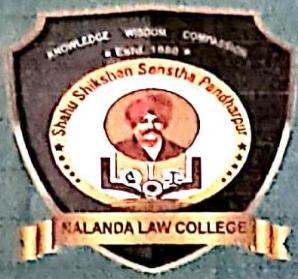
Understanding the value of working hard each semester and how it may help students in many ways—like enhancing their academic achievement and professional prospects—is crucial.

4. Working with actual legal issues and clients exposes people to moral conundrums and obstacles, which helps them hone their moral judgment in real-world situations.

5. Evidence of Success:

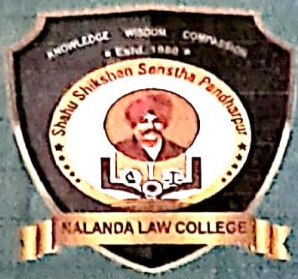
1. The feedback that the students gather each year makes it very clear that these internal examinations have been implemented successfully.

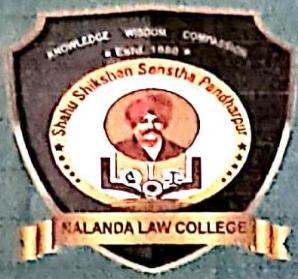

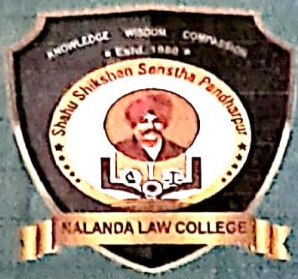

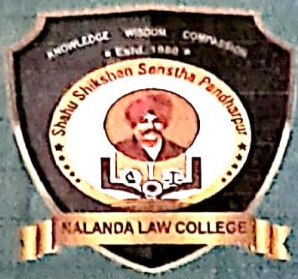

3. *The Context*

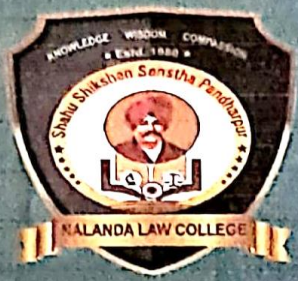

The following results show how successful the activities were:

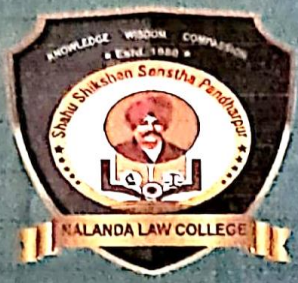
1. Having been in operation for many years and planning a large number of worthwhile events, such as debate sessions, client counseling sessions, and moot court competitions.
