Item No.1(b):

To consider the email letter dated 09/05/2024 received from Yeshwant Mahavidyalaya, Wardha (LLB5091) running L.L.B. V years course.

"Discussed.

The Institute running the L.L.B.V years course has not submitted the proposal for approval of fees for the academic year 2023-2024. Therefore, the explanation was sought from the Institute. In response to the letter/notice issued by the Authority the Institute has offered explanation as to default in submitting the proposal within the period prescribed. The



Institute has requested to allow the Institute to submit the proposal by opening the link.

On due consideration of the explanation put forth and submission given that the Institute has committed the default in complying the provision to submit the proposal for approval of fees within the time prescribed. The Management running the Institute has committed violation of sec 14 (1)(a) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015, (hereinafter referred to as 'the said Act of 2015') and thereby invited penal consequences as provided u/s. 20 of the Act of 2015. Considering the fact that the Institute has offered explanation and default being first default it was decided to imposed the minimum penalty as prescribed u/s. 20(1) (a) of the Act of 2015. The Authority cannot impose the penalty less than the minimum penalty provided u/s. 20 of the Act of 2015. It was therefore decided to allow the Institute to submit the proposal for academic year 2023-2024 subject to penalty of Rs. 1 lac. The link be made open to enable the Institute to submit the proposal. The link be kept open for a period of two weeks from the date the intimation is send to the Institute opening of link to submit the proposal. The payment of penalty shall act as condition precedent to entertain the proposal.
